FPC19-113 Apologies for absence

Apologies for absence were received and accepted from Councillor Teixeira-Gomes and District Councillor N Mison.

FPC19-114 Declarations of Interest

It was AGREED that any declarations of interest would be stated by Members as required during the meeting.

FPC19-115 Minutes of the Parish Council held on 27th January 2020

The minutes of the Parish Council meeting held on 27th January 2020 were accepted as a true and correct record and signed by the Chairman.

FPC19-117 Nottinghamshire County Council

(a) <u>Local Improvement Scheme – Application Update</u>

The Clerk circulated the final pattern from the designer for approval. It was noted that the colours of the wax and clay did not represent the colours that will be used on the final sign. When it is hand painted, the colours from the artwork will be used.

This was noted and AGREED.

(b) Notice of Submission of Nottinghamshire Minerals Local Plan

Members noted information regarding the current position with the production of a new Nottinghamshire Minerals Local Plan.

(c) <u>Highways Issues</u>

The Chair drew Members' attention to the PA Freight entrance on Farndon Road, which had now closed. Vehicles were now using the new entrance from the A46 roundabout. It was hoped that this meant Highways England were now closer to removing the cones and signs and completing the roundabout. The Clerk was asked to contact seek clarification from Highways England.

(d) Advance Notice of Public Consultation on Nottinghamshire & Nottingham Waste Local Plan Issues & Options Document

The Clerk referred to advance notice of public consultation on the Waste Local Plan, which would be open for comments between 27th February and 9th April 2020.

FPC19-118 District Councillor Session

The Chair suspended the meeting at 6.38pm to allow District Councillors to present their report.

Councillor I Walker referred to the refusal of planning permission for a bungalow on land off California Road. If the application were to go to appeal, in his opinion, it would be permitted. Councillor K Walker disputed this and would continue to oppose any development on this land due to highway issues.

County Councillor Mrs Saddington asked for details of the application number to liaise direct with Highways, should it go to appeal or be resubmitted in an amended form.

Councillor I Walker advised that the Parish Council should expect an application to develop the garages off The Meadows. Plans were currently in the design phase.

The Clerk referred to what appeared to be a 'land grab' where boundaries had extended into the Parish Council's land behind The Meadows. It was suggested that the Legal Department at Newark & Sherwood District Council be notified.

(a) Open Space Strategy – Notification of Site Visits

The Clerk advised that the District Council was currently updating its evidence base regarding open space provision across the District. Researchers will be undertaking site visit assessments to some areas.

FPC19-116 County Councillor Session

With the arrival of County Councillor Mrs Saddington, the Chair suspended the meeting at 6.48pm for her report.

Cllr Mrs Saddington referred to correspondence relating to the Village Green. The County Council were sympathetic to the situation but there were legal problems that needed to be addressed. The matter would continue to be reviewed.

The Clerk referred to recent closure of Footpath 3 (to the rear of Sandhill Road) due to flooding and the loss of a 100 year old Oak tree. The closure had been agreed with

FREG had undertaken litter picks in both January and February. The riverside litter pick will take place in March, weather permitting.

Mr Dodson asked if a firm response could be given regarding the proposal for permanent Christmas Lights at the green. The Clerk to review correspondence with Via and liaise with Mr Dodson.

The Chair queried an item in the minutes relating to the potential donation of lights for the green on Marsh Lane opposite the Londis store. Mr Dodson confirmed this was not being considered at the moment, connectivity would be an issue.

The Chair thanked Mr Dodson for his report and reconvened the meeting at 6.58pm.
